Verification of the Inforce reports should include (but is not limited to) the following actions:

- 1) Verifying that the net amount at risk and all policy details are accurate.
- 2) Finding policies not on this report that should be reinsured.
- 3) Finding policies appearing on this report that should be terminated.

If you have not fully verified your inforce listing and an Errors and Omissions (E&O) request is submitted, you will be requested to do so before the E&O is considered for approval.

Our year-end Inforce reports are distributed during the first week of January. If you are not already receiving Inforce listings on a quarterly basis and would like to, please contact us at oric.admin@optimumre.com.
