Investment objectives

The objective of the Optimum Long Term Bond Strategy is to obtain income and capital security over a long-term horizon and generate an average annual return of **0.50% above** the benchmark over 4-year moving periods (before management fees).

The Strategy favours sector rotation based on economic and geopolitical issues. The management team combines quantitative and active management to reach a consensus on the magnitude of the tactical deviations to be adopted.

The portfolio is comprised primarily of fixed-income securities issued by Canadian issuers. Provincial and municipal government securities and corporate securities are generally favoured.

The management style is based on interest rate anticipation, sector weighting, yield curve positioning and security selection.

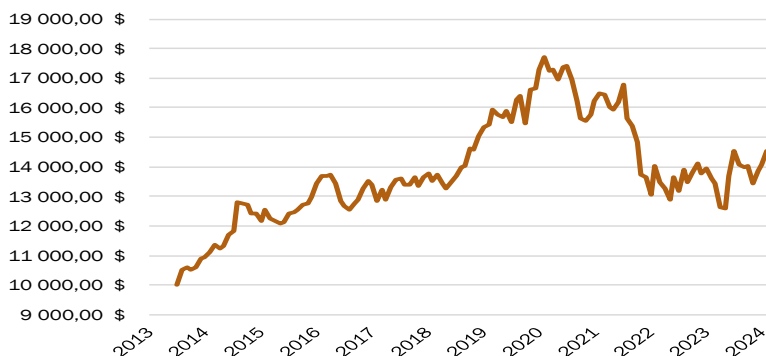
Risk rating

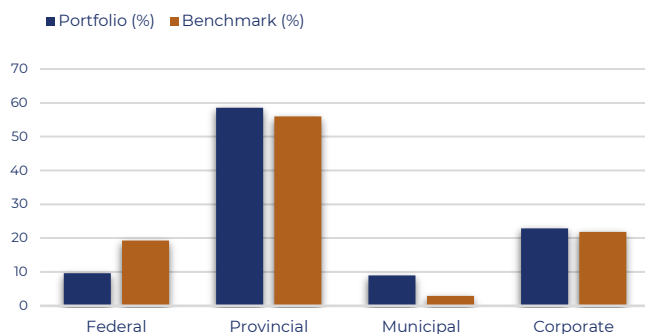
