Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?**

The types of information we collect and share depends on the product or service you have with us. This information can include:

- Social Security number (or Tax ID number) and wire transfer instructions
- Account balances and account transactions
- Investment experience and risk tolerance

When you are *no longer* our customer, we continue to share your information as described in this notice.

**How?**

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the Optimum Quantvest Corporation chooses to share; and whether you can limit this sharing.

### What we do

<b>How does Optimum Quantvest Corporation protect my personal information?</b>	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>We maintain physical, electronic, and procedural safeguards to protect and dispose of client information. Our client website is secure. Access to client non-public personal information is limited to authorized personnel.</p>
<b>How does Optimum Quantvest Corporation collect my personal information?</b>	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> <li>• Enter into an investment advisory contract or give us your contact information</li> <li>• Seek advice about your investments or make deposits or withdrawals from your account</li> <li>• Provide account information</li> </ul> <p>We also collect your personal information from other companies.</p>
<b>Why can't I limit sharing?</b>	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> <li>• Sharing for affiliates' everyday business purpose-information about your creditworthiness</li> <li>• Affiliates from using your information to market to you</li> <li>• Sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>

### Definitions

<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <p>Affiliates we may share your information with are Optimum Holdings Inc., Optimum Group Inc., Corporation Optimum, Optimum Asset Management Inc., Optigam Inc., and Gamopti Inc.</p>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p>
<b>Joint Marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <p>Optimum Quantvest Corporation does not jointly market.</p>
